*** **Unskilled Respite Services – No more than 30 days or 720 hours of respite care services per contract year (July 1st through June 30th) per person. If DD ALTCS eligible coordinate with DD Support Coordinator to ensure that no more than 30 days or 720 hours total of respite is used between the two programs.**

****** Discharge from an inpatient setting of Title XIX/XXI persons must be communicated to the person's PCP in accordance with [Section 4.3, Coordination of Care with AHCCCS Health Plans, Primary Care Providers and Medicare Providers](#).**

For Level I facilities designated as Institutions for Mental Disease (IMD) – For Title XIX members age 21-64, only 30 days per admission and 60 days per contract year (July 1st through June 30th). However, Title XIX eligibility continues past the 30/60 day limitations.
